Applicable within entire service territory served, with the exception of the Jones Run area.

MUNICIPAL EXCISE TAX SURCHARGE

The municipality listed below, having imposed a public utility tax computed on the basis of two percent of revenues from water sales by the District within the corporate limits of such municipality, said tax shall be billed as a surcharge to the customers receiving service within said corporate limits.

The water utility is required to collect the utility tax pursuant to ***West Virginia Code §8-13-5a***.

Customers receiving water service within the corporate limits of the specified municipality shall pay a surcharge based on the following surcharge rates:

Municipality: Town of Smithfield Utility Excise Tax 2%

DELAYED PAYMENT PENALTY *

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION CHARGE - \$20.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the District up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by their bank due to insufficient funds.

SCHEDULE III (Continued)**TAP FEE**

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$350.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the service.

LEAK ADJUSTMENT *

\$6.57 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above 200% of the customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two times the average monthly bill for the applicant's specific customer class or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

(C) * 8.11% CASH WORKING CAPITAL RESERVE INCREMENT

8.11% of total billings at the indicated rates is required to be recorded as a credit to Account 265 "Miscellaneous Operating Reserves," (instead of revenue accounts). The utility shall apply that same percentage to total monthly tariff collections and charge that amount to Account 127 "Other Special Funds" (instead of cash) and deposit that amount into a separate distinct CWCR Bank Account.
